After retrieval of luggage, contact hotel 888-747-1900 for shuttle. Also free scheduled service to Historic District and within a two mile radius of hotel, which includes Tanger Outlet Mall.

Chair Lee Doyel opened the meeting at 9:30 am. After several opening remarks he moved on to the meeting agenda.

Secretary's Report

Mel Harder gave the secretary's report. He reported on the maintenance of the active member list and crew lists; current membership and the issuing membership cards; and the YAGRGRAM. Currently 500 active YAGR members receive the YAGRGRAM, published three times annually.

From Bob Philipp - USS Vigil, AGR-12

I served aboard the USS Vigil from February 1962 to July 1964. I was certified as an air intercept controller and for most of the time was the CIC or Operations Officer. On Monday, September 22, 1962 at 1900 JFK made his public pronouncement of the "quarantine" of Cuba. At the time we were on picket, I believe on station 18, the southernmost

operational east coast station. We were coming to the end of a long and weary picket, having endured two hurricanes earlier in September. I had just qualified as OOD and had the 20-2400 watch that night. We, of course, had heard JFK's speech and were wondering what it would mean for us. We had a lookout that watch, his nickname was "waterbottle". His real name was difficult to pronounce and even more difficult to spell, so he became waterbottle to one and all. He kept reporting seeing bright flashes of light to the south. Of course we all were thinking Atom bombs? Of course it was nothing, possibly lightning. The next day we went from DEFCON 5 to DEFCON 3.

A few days later we were still on station, having been extended at sea because of the crisis and the activation of station 20, another 200 miles closer to Cuba. I had the 12-1600 watch. Because of the crisis, we had put live shells in the 3"50 gun mounts fore and aft. About 1300 the lookout in the forward mount reported smoke coming from the gun. Smoke=?fire and live ammunition. I called general quarters even before notifying the captain. The boatswain of the watch got on the 1MC and announced "Fire, fire in the forward gun mount. This is a real fire" That got everyone moving. It turned out to be just an electrical problem which the EMs were able to correct quickly and the panic was over.

One other memory. Shortly after the 22nd an ASW carrier task force steamed by headed south. The TF commander ordered us to join his convey. Since we were under NORAD control and doing what we thought was a vital mission where we were, our CO, CDR Rawson, thought that was a bad idea. But rather than trying to explain the chain of command, etc. to an admiral, he merely replied that our top speed was 11 knots. The quick reply was to the effect of "OK-stay where you are and continue present duties."

Khrushchev announced that the missiles would be removed from Cuba on Sunday October 28 and we were released and returned to Davisville sometime thereafter-a three week picket having been extended to about five weeks as I recall. In preparing this account, I referenced "To the Brink-JFK and the Cuban Missile Crisis" a 2012 publication from the National Archives which is a good, factual account of the crisis, which actually began that preceding Summer when U.S. Intelligence detected Soviet military shipments to Cuba. That book has many picture, maps and copies of many of the pertinent formerly top secret documents, along with a good bibliography for anyone interested in more details.

While emailing another retired Chief, and reading his "sea stories " about borrowing a Shore Patrol vehicle with the keys left in the ignition...it occurred that I had one of my own. After making RD2 in October 1964, I was awarded the Shore Patrol duty at the Davisville Enlisted Club outside the main gate. This turned out to be a rather uneventful evening which was great because this was my first SP duty. At 0200, the club closed and those who were on the ships gathered inside of the main gate and waited for the bus back to the pier. There were about eight guys, and since it was winter and a little cool waiting for the bus that was way to slow, whatever was consumed at the club came into play. whoever threw the snowball that hit

the back of the head of the Marine gate guard, well that started it and by the time the Sergeant of the Guard, then the Officer of the Day were on scene things got ugly. Unfortunately I did not think to take the armband off and the OOD spotted me. I was asked if I had observed the person who perpetrated this breech of military decorum and truthfully denied any involvement. The direction I received was to take each individual to the ships quarterdeck and turn them over to the OOD and explain the circumstances (with a straight face). I never heard anything more about the incident, and as the statue of liability is long gone my question is there anyone in this group (RadRon 2) who can add some information on this dastardly deed? or better yet who will like to try out as pitcher for the Yankees.

From Kenneth R. Wehr - USS Skywatcher, AGR-3

I served on the USS Skywatcher as a DK3 from July 64 to March 65 when we were decommissioned.

I have two stories: Story 1 - The Monday before Thanksgiving we left Davisville and headed for one on the northern picket stations. Just prior to our departure the news reported that the ocean liner Independence had encountered heavy seas, some as high as 60 feet, which caused damage to lifeboats and windows. We were headed to that same general area and the seas were rough on the way to the station and on Thanksgiving we encountered 30-40 foot seas. Very few



attended our holiday meal as most were seasick, including the Capt. and the XO. Turkeys and hams in pans were flying out of the ovens on to the deck and the mess crew had all they could do to get the food back in the trays and back in the ovens and served. You really had to hold on to your trays and mugs to get through the meal to say nothing about eating fast. The seas abated the next day becoming slow ground swells instead which caused additional seasickness. Years later, while watching the movie "The Perfect Storm", it brought back fresh memories of that time. I mentioned to my wife about my experience and she remarked that she was glad she didn't know it at the time. Story 2 - At some point while on board the Skywatcher we experienced a series of thefts. One was

of strawberries or strawberry ice cream (can't remember which) and the other involved the theft of a crewman's guitar. Both occasions precipitated inspections of the entire ship including the crew's personal lockers. Nothing was found. Soon after, one of our First Class cooks was seen around the ship with a paperback book sticking out of his back pocket with the title "The Caine Mutiny " showing. It wasn't long before the XO told the cook in no uncertain terms that he didn't want to see it again and that was that.

Memo from Lee Doyel, Chair - registrations, payments, ship's store

I forgot to mention it at the business meeting that all the prices for reunion tours, hotel, etc. include gratuities. It is not necessary to tip bus drivers, tour guides or other associated persons.

When ordering reunion shirts USE THE REGISTRATION FORM even if you are not attending the reunion (add \$5 for mailing). Just fill out the shirt portion only. If later you want additional shirts (as long it is before the cut off date) use another registration form. This year some were ordered by other means and caused some confusion which resulted in a shortage of some sizes. In that regard, the REGISTRATION FORM WILL BE THE DECIDING FACTOR in any questions that may rise regarding shirts, payment for tours, banquet, guest, etc. If there is something unique or different about your registration, MAKE A NOTE ON THE FORM so the Treasurer will know how to handle and credit it. I had one X-large and three XX-large left over. Reduced price. \$10 each. Be advised sizes have run large.

We are going to change the registration form so it will reflect that a member in good standing and one spouse will pay the reduced rate. That is, two persons will receive the regular registration fee. Additional guest(s) and non current member(s) will pay the higher rate. A non current member can by catching up on his dues get the lower rate for him and his guest. Widows who are current in the dues also get the lower rate. If there is a widow who cannot afford the dues cost, there is a fund to help the widow.

When paying for anything related to YAGRS (registration, tours, ship's store, etc.) ALWAYS MAKE THE CHECK OUT TO YAGRS, not to the treasurer. It causes problems otherwise.

On occasion members take advantage the lower hotel rate and register at the hotel under the YAGRS room block and do not attend the reunion activities. Generally this does not cause a problem. However it can cause a problem when we run up against the maximum number of rooms we have blocked out. It means we have to ask the hotel to expand the number of rooms in our block of rooms. If this occurs before the cut off date for registration, the hotel can (at their discretion) give us more rooms. However if the hotel refuses, individuals trying to register, even before the cut off date, end up paying a higher rate. As registration at the hotel proceeds I receive a list of registrants. I check that list against the registration forms the Treasurer has received. If the lists don't match I start looking of the reason. So if you use the YAGR rate for other purposes (family reunion, vacation, etc.) than the reunion please SUBMIT A REGISTRATION FORM explaining why you used the YAGR rate. This helps upkeep things in order and from "chasing rabbits." If an individual registers on the YAGRS rate and the room block is full I may have to ask the hotel to remove you from the YAGR rate so a reunion attendee can utilize the YAGR rate. Reunion attendees have first priority to the YAGRS block of rooms. Others will be on a standby basis.

During each reunion things occur/happen which I call "HICCUPS." Some of these at this reunion were beer in bottles (required cups for outside), rain at the luncheon (had to move off the patio), 2 river boats vice 3, arriving late at the mission (different route for meg bus), reunion shirts running large in the sizes, etc.

On occasion some members arrival early for some reason or other and ask if they can be included on a tour they had not signed up for. I will try to accommodate those individuals if possible. However you must realize it will depend on the number of seats open on the bus, tour site/restaurant is able to accept an addition, etc. Naturally the individual will be expected to pay the Treasurer for the cost.

I need to make an apology to Pat and Diane De Riso who hosted this reunion. I failed to mention it at the business meeting. They provided all the snacks and kept the bowls filled. Although they live over 300 miles from San Antonio in McKinney (north of Dallas) they volunteered and came through. Proved we don't necessarily need an on site host.
